



I had been trying out a new social media platform that a friend had recommended - MeWe - and as they're an interest I'd joined a number of firearm and weapon groups. In one of the weapon groups I'd met a user who I began to speak with fairly often, at least for awhile. For some 15 years now I have designed various weapon systems. Those I designed ranged from basic small arms and body armor... to four stage fusion devices, artillery, cruise missiles, torpedoes, and more. One day, as we were discussing a recoilless 6.75mm battle rifle that I had designed, he randomly asked if I had ever considered moving to Russia. I'd explained to him in conversations before that the heat of Texas was very hard on me due to having MS, and he used the weather... and then the pay that being a weapon designer there offered... as selling points for me to move to Russia. I, of course, turned him down and told him that my long term plans involved getting my Manufacturing or Gunsmithing FFL, and trying to sell them to the DoD. I did not hear from him for days, then heard from him again... he told me that "no" had consequences. I've tried to report this ranging from the police up as high as I could, and keep family out of it... and now I find myself facing charges for a crime I had no motive to commit, and when I rectified it I was still promised jail... despite giving proof from my side that I did not commit it. In Texas I will die in jail, due to neither medication that I take that makes me functional, physically, through my MS allowed in their jails, the withdrawal from both at once is fatal, and I've been flat told that things like this do not "happen in real life." Well... it has. I suppose my end doesn't really matter, but someone needs to be told that there is someone on that app with the ability to literally reach out and touch people who have unique weapon ideas... and then turn down their offer of employment in Russia. I only have until Tuesday, but I hope this person is found.
