

Yes, I believe so.

Synopsis

The subject was [REDACTED]

[REDACTED] I met him once around 2012 in a Christian fellowship. He attempted to recruit people to join Chinese Students and Scholars Association. He bragged about how his organization was financed by the Chinese embassy/consulate in the United States and how they used the money to recruit Chinese international students. He also encouraged some Chinese students to commit identity fraud. I don't remember the detail, but I do recall that he told some Chinese students to use other Chinese student's S-100 ID card to claim some benefit. He said "westerners can't tell Chinese apart. Just use other people's ID".

I distanced myself from the subject after that time. I disapprove Chinese Communist Party to begin with. And I feel the subject is an unethical person. He was at the front line of helping Chinese Communist Party to spread its influence, and probably spying on international students.

I later spotted him working in a restaurant in the nearby area called "Panda House". I'm afraid he did not have authorization to work on that job. The restaurant was shut down a few years ago.
